# Jefferson EDGE 2020 BEAUTIFICATION Status Report 3: October 2010

Prepared by JEDCO and GCR & Associates, Inc.





#### **Beautification**

In response to concerns about quality of life in Jefferson Parish and its impact upon the community's economic competitiveness, JEDCO initiated the Jefferson Edge 2020 Quality of Life initiative. This initiative has produced eight "strategic implementation plans" which include a series of action items to address particular quality of life issues. Implementing the action items requires the total cooperation and keen interest of all involved, including JEDCO, the Jefferson Parish government, numerous other entities, and frequently State and Federal agencies. In 2008, JEDCO retained GCR & Associates, Inc. to prepare semiannual reports outlining the status of each of these action items and overall progress toward implementation.

The following table summarizes the progress made toward each of the beautification (B) action items.

The concept of an independent governing authority to oversee such an initiative has been raised, but this concept lacks a political champion.  A potential jumping off point, however, is a set of grants recently issued jointly by HUD, the federal Department of Transportation, and the EPA to support "livability" and "sustainability." JEDCO and Jefferson Parish have been involved in the preparation of a regional grant application for the maximum amount of \$3,000,000. This grant would support efforts to improve transportation alternatives and the overall quality of the Judge Perez/ Claiborne/ Jefferson Highway corridor in St. Bernard, Orleans, and Jefferson parishes. This grant will be submitted in the fall of 2010.	Monitor the progress of the regional grant applications submitted to HUD/DOT/ EPA. If the application is successful, ensure that the resulting project addresses many of the objectives outlined in the Boulevards Initiative.

While the Parish was unsuccessful in securing a \$1.4 million grant from the State to upgrade Jefferson Highway, a number of other improvements are in the works:</li> <li>The two Parish-wide beautification non-profits, Friends of Jefferson the Beautiful and Jefferson Beautification, Inc. have donated approximately \$50,000 worth of trees to be planted along Jefferson Highway from Causeway to the Parish line.</li> <li>Greg Cantrell has completed design work for landscape upgrades to Jefferson Highway; these landscape improvements will be implemented when funding is dedicated.</li> <li>Greg Cantrell is also finalizing design work for similar landscape improvements to Lapalco from Brooklyn to Berkeley Drive.</li> <li>Greg Cantrell has also completed design work for Bonnabel Blvd. from Metairie Road to the Lake. The two beautification non-profits have pledged a donation of \$30,000 – \$40,000 in trees to implement these landscape improvements.</li> <li>Veterans CPZ funding has been bonded out for \$3 million worth of landscape improvements, which will be funded simultaneously. Phase IV of the Veterans beautification project (phases I – III are largely complete) will begin in October of 2010; phases V and VI will be put out to bid in the subsequent months. All phases should be completed by the middle of 2012.</li> <li>The Parish is already looking at the next phase of corridor improvements. Dickory Street will likely be one of the next targets for beautification upgrades.</li> <li>Jefferson has received recognition for these efforts. Jefferson recently was named a winner of the 2009 Quality Vegetation Management Habitat Award for its work in maintaining turf and trees, applying herbicide in a sensitive manner, and restoring canal banks.</li> </ul>	Monitor the progress of landscape, streetscape, and public art projects underway. Secure funding to transition projects currently in the design stage into the construction stage. Continue to seek funding for a comprehensive boulevards study to set the stage for further capital improvements.					



B1c	Implement a gateway improvement program with a principal emphasis on the corridors abutting the airport	Secure local funding and pursue external funding in 2009; secure interagency agreements in 2009; initiate project in 2010; complete by 2013	There are two major components to Jefferson's gateway improvement program: signage and landscaping at the major entrances to the Parish and major aesthetic improvements to the entrance from the airport. For the first initiative, design work is complete, and the only remaining obstacles are permitting from the State along State roadways and funding to implement the designs.  For the second initiative, Jefferson was successful in obtaining a \$1.6 million Transportation Improvement Program grant. Design work is currently underway, and cooperative endeavor agreements with the airport and the City of New Orleans are being finalized to ensure the continued maintenance of landscape improvements. The focus of the improvements will be along the airport access road and along the north side of I-10 from the airport access road to the Veterans Boulevard interchange.	Secure Parish funding to complete signage and landscape improvements at major entrances to the Parish.  Finalize cooperative endeavor agreement with the airport and City of New Orleans to implement improvements to the airport approach. Reach out to the East Jefferson Business Association to secure their cooperation and participation in funding these improvements.

Another major obstacle to this program is the absence of a funding source. Enlisting the cooperation of the Chamber of Commerce and the local garden clubs may be a partial solution to the funding problem and may spur enthusiasm for this kind of initiative.	Focus efforts on the commercial properties that are on the same corridors as those that are undergoing improvements to the rights of way (e.g. Jefferson Highway and Lapalco). The most high profile change is the recent adoption of three new zoning districts for Fat City (see the EDGE 2020 plan for Fat City for further detail). The districts establish stringent, unprecedented standards for new development that will result in more aesthetically pleasing treatment of signage, parking, and overall building quality. These Districts were approved by the Parish Council and could serve as a template for further revisions parish-wide.  The Parish also continues to migrate the zoning ordinance into a "Unified Development Code" in Chapter 33 of the Parish Code of Ordinances.  Another major initiative is a forthcoming study by the Planning Department to strengthen zoning regulations along Airline Drive. To be completed no later than December, 2011, the recommendations of this study could be the foundation for changes in zoning to other corridors in the Parish.  Meanwhile, other potential changes to the zoning ordinance, such as comprehensive revisions to the Parish's signage regulations, are somewhat dormant at this time. Care must be given in designing such a program to the types of trees that would be permitted and the desired locations for the trees. As a funding source and a programmatic template are not in place from Parish government, the most likely catalyst for this project will be the non-profit sector. Unveil in 2009	There are two major prongs of Jefferson Parish's ongoing quality of life outreach effort: Jefferson Life magazine and JEDCO's annual marketing budget (approximately \$200,000 for 2010-2011). Jefferson Life is already covering its production costs through advertising revenues and has increased production to six times per year. Twice per year, Jefferson Life will cover each of the quality of life issues addressed by Jefferson EDGE 2020 to update the public on progress underway.  Additionally, JEDCO's annual marketing budget goes toward print advertisements, billboards, radio advertisements, and social media efforts. Collectively, these marketing efforts spread news about positive developments in all aspects of quality of life.	Given the fact that Jefferson Life magazine is sustaining itself through advertising revenues and given its expanded production schedule, this action item is effectively complete. The health of Jefferson Life should continue to be monitored, and JEDCO should remain vigilant in pursuing additional marketing funds.

There has been no momentum on this aspect of the public art initiative as no "champion" for this initiative who is in public office has been identified. Work with the Jefferson Chamber and other potential private/non-profit funding sources to gauge their interest in pursuing this initiative. Coordinate with the Parish Council and Administration to determine the feasibility of receiving local funding for this project.
