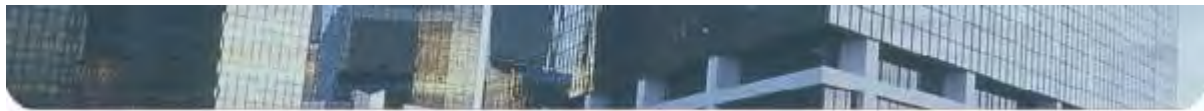

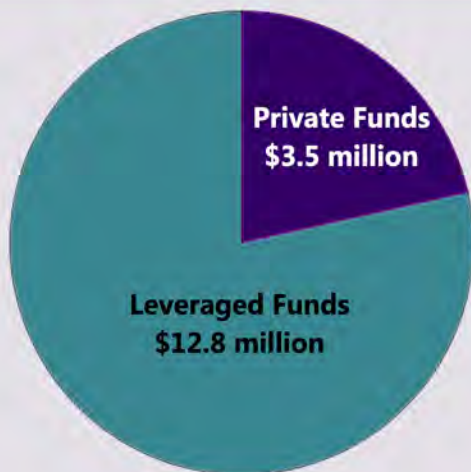

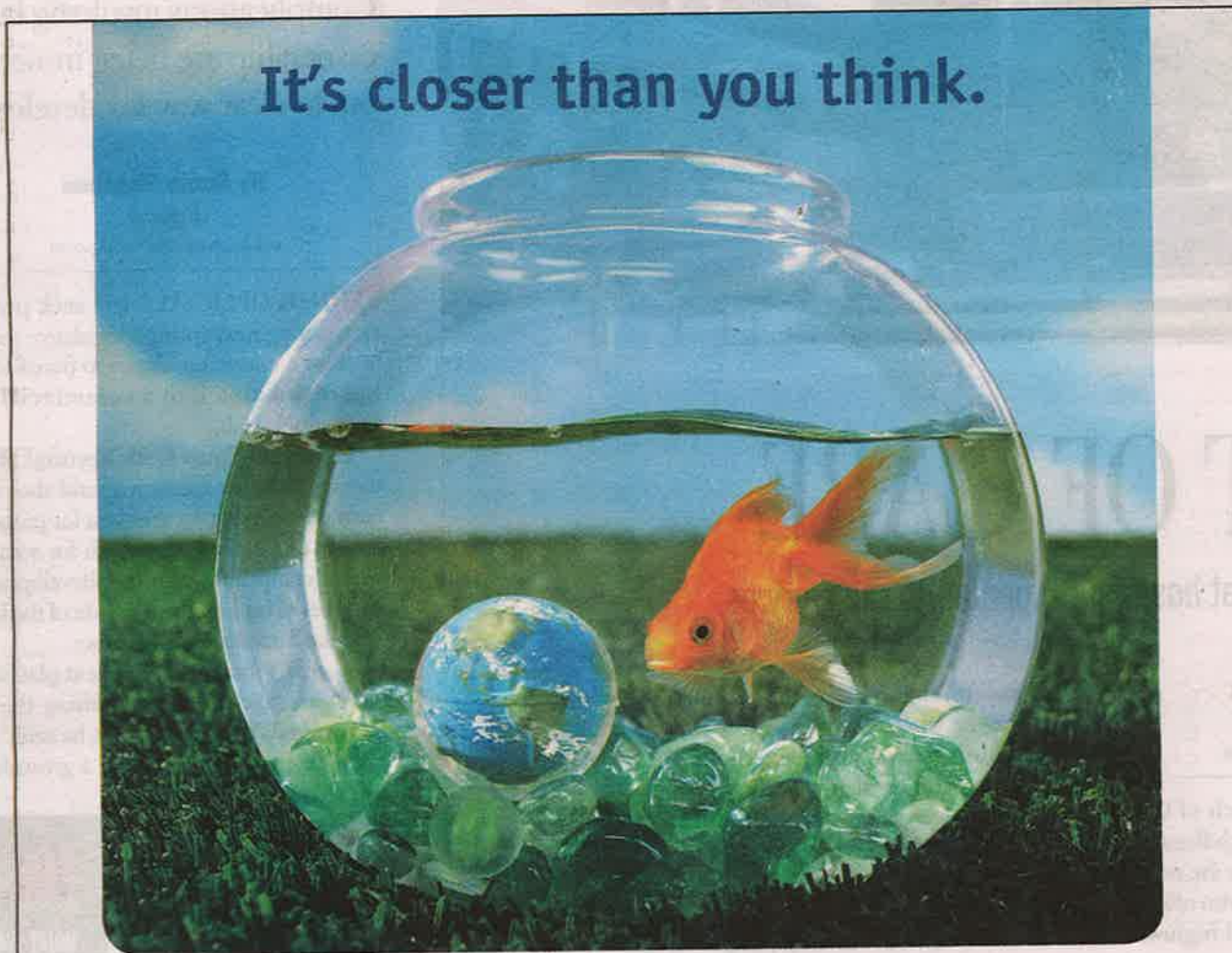
would be part of the process of finding a private developer for the property.

“Once a developer has been identified, the state would then negotiate a fair market value lease of the land involved in the proposed development,” Quigley said. “The state would get 100 percent of the rental value and the city would benefit from any sales and property taxes generated from the new development.”

Talks to develop the land at the lake end of Williams Boulevard stretch back to the early 1990s. In 2008, the city created a master plan for the area that included an amphitheater, a skateboard park, condominiums, retail stores and a boardwalk along the lakefront to go along with walking trails and a fishing pier. A lack of fund-

ing from the city and the inability to sell state-owned land hindered those projects.

As for what would go into the new development, Quigley said the developer would be responsible for bringing a plan to the table, but the city has its own ideas in mind.

“We have already done some surveys and studies as to what residents would like to see there,” he said. “Anything that is done out there will likely include seafood restaurants, nightlife, public common areas, new retail development and more access to the lake. There is a wealth of possibilities.”

Bruce White, owner of the Coco Beach volleyball complex, was lured to the spot just south of the Laketown area last summer after the U.S. Army Corp of Engineers took over its former location in the West End for its hurricane protection projects. He said the Kenner location gave him more room to grow, and any new development along the lakeshore would be a positive.

“In the years after Katrina, Coco Beach was one of the only things still operating out in the West End area,” White said. “When we finally started construction in Kenner, there were more people watching us build than there were customers at the location. Here we have the Pontchartrain Center, the casino and the retail along Williams. There is a lot of visibility.”

Reynaud said the city would like to submit its request for proposals by the end of the year so the project can move forward.


“Great progress has been made in the past two years, and we have to keep that momentum up,” he said. •
